1. Age as per NHM Haryana guidelines.
2. No other allowance will be paid other than on call basis fees.
3. No TA/DA will be admissible for appearing in Document verification.
4. The application shall be subjected to subsequent scrutiny and can be rejected at any point of time if found incomplete/ wrong/not fulfilling the eligibility criteria etc. No correspondence in this regard shall be entertained.
5. The candidature shall be provisional and will be subjected to verification of eligibility conditions with reference to original documents. Screening and selection will be based on the details provided by the candidate. Hence, it is necessary that applicants should furnish accurate, full and correct information in the application form.
6. Initially the hiring of specialist doctors on call basis will be upto 31.03.2026 or till the regular specialist doctor joins whichever is earlier. However, this may be extended further as per requirement or may be terminated at the discretion of Competent Authority without assigning any reason thereof.
